The approval is based on a curatorial perspective, considering applicants who show a distinct artistic approach, collaborative reliability and high professionalism. Further requests for additional support documents or a peer-review may be part of the evaluation process. An Artist Pass has a validity of 5 (five) years since issuance.

Special certification letters can be issued, at request, with a short-term validity (one month).

A renewal of the Artist Pass is based on same application dossier. We do not inform the artist on the expiration of the Artist Pass.

A cancellation of the application, once submitted, is no longer possible.
